Kevin Pelletier – Resident and business owner commented that properties have been reassessed unfairly.

James Ouellette – Resident read a prepared statement requesting that Council consider suspending the late penalty for property taxes for the remainder of 2021.

Jeff Armstrong – Resident and business owner stated that he is a "proponent of fairness" and the reassessment of properties is "totally unfair" and wants a reason why when there is no growth in Fort Fairfield. Stated that his home assessment increased 50% and his business increased over 74% and his business property <u>land</u> went up 300% and there is a commercial property across the street from him with the same acreage and same commercial use and that property went down by 3%. "I can only conclude that someone didn't do their due diligence, I don't know where they got their numbers." "Some people's taxes went down and other went up and I'd like to have an answer as to why that happened." "I have talked to Tony (Levesque) and he didn't have an answer."

Chuck Ainsworth – Resident since 2016 commented that transparency is critical. "I am all about our EMS service and Fire Department and Police Department, but at the same time if our expenses are going up and we've seen big, big expenditures in those departments and we don't see where that extra money is coming from and we lose big tax bases like the Energy plant and we replace them with things that we can't even get tax

revenue from then what is the point of bringing those businesses to Town. Mr. Ainsworth asked that Councilors "look" over their decision and evaluate it. "Look to the future"

### B. Earned Paid Leave Policy

Discussion: On January 1, 2021 Maine's Earned Paid Leave Law was put into effect. (Public Law 2019 Ch. 156, "An Act Authorizing Earned Employee Leave"). This law applies to employers with more than 10 employees in Maine for more than 120 days in any calendar year. Employees accrue 1 hour of Earned Paid Leave for every 40 hours worked, up to 40 hours in a defined year. Employees can use their accrued Earned Paid Leave for any reason such as an emergency, illness, sudden necessity, planned vacation, etc.

Recommendation: Council votes to accept the new Earned Paid Leave Policy 9.1.7 to be put into the Personnel Policy.
